

# Landis Communities Update February 10, 2021

The past week has brought much hope and relief as Landis Communities has been able to move forward with plans for COVID-19 vaccine clinics on the Landis Homes campus. Our partner, Phoebe Pharmacy, tells us **we remain on track for the clinics scheduled for February 23 and 24!** Team members have been busy contacting residents who qualify at Landis Homes and Steeple View Lofts, clients of Landis Adult Day Services and Landis at Home, members of the Lancaster Downtowners and those enrolled in Friends LifeCare who are eligible to receive the vaccine. The response has been incredible! Thanks to all who are willing to take this step for the health and wellbeing of all.

We are currently plugging all interested persons in to a master schedule based on your availability. You will receive a phone call before the end of the day on February 16 with your exact time. Please be patient and wait to receive your confirmation phone call.

The location for the clinic is West Bethany Chapel. We have been informed that the Moderna vaccine is the one to be administered at the clinic. That means the second dose will be given four weeks later. Please hold this date on your calendar.

As we have shared, it is the goal of Landis Communities to achieve at least an 80-85% vaccination rate for team members, residents and clients. A new report will be available soon to track our progress, but the affiliate reports below will share some exciting news based on current awareness.

#### **COVID-19 Cases and Deaths**

The weekly report of Landis Communities COVID-19 cases and deaths is below. We are aware of three new cases – one Healthcare resident, one Residential Living resident and one team member who works in Healthcare. Anyone who may have had contact with one of these individuals has been contacted and precautions have been put in place.

# **Affiliate Updates**

### **Landis Homes**

- Testing for team members working in Healthcare and Personal Care continues.
   Residents in both areas are tested based on regulations and as needed due to possible exposure.
- Visitation
  - The Residential Living Reopening Plan dated January 14, 2021 remains in effect. All visitors must continue to be screened at self-screening stations in Crossings or Residential Living entrance and receive a name badge.
  - Healthcare and Personal Care visitation guidelines were detailed in the update lastweek. Please check the website for this document and the full reopening plans for both areas.

• Vaccination rates from clinics on the Landis Homes campus are currently 86% for Healthcare and 85% for Personal Care residents receiving at least one dose. With several team members scheduled for a first dose this week, approximately 50% of staff on the Landis Homes campus will have at least one dose of the vaccine. Based on recent calls, we estimate that with those who have already been vaccinated, those who have appointments scheduled and those who will receive a first dose at the February 23 and 24 clinics, the vaccination rate for RL will be 85-88%!

#### **Welsh Mountain Home**

WMH is eager to reunite residents with their loved ones so we are closely watching the Lancaster County positivity rate, currently at 9.9%. This is within the Department of Health guideline for visitation to resume (under 10%) but we are taking extra precautions and waiting for residents and team members to get their second dose of the vaccine on February 18. We plan to start accepting calls for appointment scheduling Monday 2/22 as long as the county positivity rate stays below 10%. Visitation will be by appointment only and observing the 3W's as per the CDC and DOH recommendations. Please watch the WMH Facebook page and website for information regarding reopening. Sarah Albertson, Director of Resident Services will be handling appointment scheduling. After the second clinic date, we estimate 80% of residents and 48% of team members will have received at least one dose of the vaccine.

#### **Landis at Home**

Landis at Home clients are excited to participate in the COVID-19 vaccine clinics on February 23 and 24. Clients were mailed a letter about these clinics with their January invoice and phone calls were made to clients or family members at the end of last week and early this week to confirm participation. Landis at Homes clients with questions about the clinic can call 717-509-5800. We are thrilled to offer the vaccine to our clients!

# **Landis Adult Day Services**

We are encouraged by the drop in the Lancaster County positively rate last week to 9.9%. If it remains below 10% for two consecutive weeks, ADS can begin to plan for reopening the center. We are grateful to be able to offer the COVID-19 vaccine to our clients at our upcoming Landis Homes vaccine clinic. It is a wonderful thing to be able to continue to serve ADS clients and their caregivers in this way.

# **Steeple View Lofts**

Steeple View Loft residents are very excited and relieved to be able to get vaccinated at Landis Homes during the upcoming vaccination clinic. We understand that 28% of SVL residents have already had the vaccine or in the process of receiving it and 60% residents signed up for February 23 or 24. That will bring the **SVL vaccination rate to 88%!** 

# **Partner Updates**

**Lancaster Downtowners –** Lancaster Downtowners are grateful for the opportunity to be vaccinated at the upcoming clinic hosted by Landis Communities. Around 90 members are taking advantage, and others have been able to secure appointments elsewhere in the community.
