

Landis Communities Report August 25, 2021

This report contains information updated over the past two weeks.

The overall Landis Communities team member vaccination rate continues to climb and is currently at 65.4%.

There have been several important announcements recently, including President Biden's statement about vaccination of nursing home employees, the FDA granting full approval to Pfizer for their COVID-19 vaccine, and the PA Department of Health indicating an expectation of an 80% vaccination rate of nursing home staff by 10/1. Please know that Landis Communities leadership is actively formulating implementation plans for next steps but is also awaiting detailed interpretation of the regulations. We continue to actively encourage all unvaccinated team members and residents to receive the vaccination.

Team members, residents, clients and family members may continue to sign up for the vaccination clinics held at Phoebe Pharmacy on the Landis Homes campus the first and third Thursday of each month from 1:30-3:30 p.m. To schedule an appointment, ask questions or voice concerns, please contact Jenny Sheckells at jsheckells@landis.org or 717.381.3573.

During the past two weeks, four team members on the Landis Homes campus have tested positive – one works in Healthcare, two in Personal Care and one in Residential Living.

One of the four was a breakthrough case, meaning the person had been fully vaccinated.

None of the positive cases affected visitation or resulted in additional testing for residents. No residents have reported positive cases in this same period.

The Lancaster County positivity rate was 8.2% on August 13 and rose to 9% on August 20. The CDC Community Transmission rate for Lancaster County moved from Substantial to High, the highest level of transmission. All residents, regardless of vaccination status, are asked to wear face coverings when indoors in common spaces. Team members have continued to wear masks throughout the pandemic. Please also consider wearing face coverings when out in the greater community, where the risk is high due to high levels of community spread.
